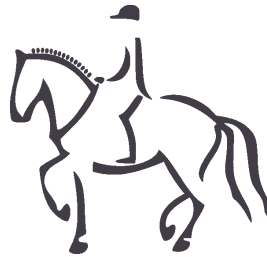

**Rules and Regulations:**

LP Equestrian Center Horse Show Management or "Management" reserves the right to interpret all questions and conditions in regard to or arising out of an incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules/Regulations shall be decided by the Horse Show Management, with their decision final and binding. The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, and cancel award prizes, without claim for damages; to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in dressage classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interests of the show. Every horse and rider combination entered for competition will be under the control of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold LP Equestrian Center, its members, directors and employees, sponsoring entities, and facility harmless for any loss or accident to their horse, horses or equipment which may occur from sickness, fire, negligence or otherwise. USDF/USEF Rules apply. Open to ALL Breeds. Shows start times 9:00AM, but subject to change, please review ride times. Changes in ride times may be made by management after the closing date and publication of ride times. Ride times are available before the show at LP Equestrian Center Facebook & will be posted at the show.

Multiple riders are permitted to show one horse, but not to exceed a total of 2 tests per horse/rider combination or 2 tests total per horse/two riders per day. Each horse can be ridden in 2 consecutive levels.

**Emergency service** will be 911.

**Concessions** to be determined.

**Tests** are the current USDF, FEI PARA EQUESTRIAN, or WDAA Tests. Horses may be entered in two consecutive levels only. Riders may have all tests read. LP Equestrian Center test scores may be submitted for MDA,WDAMI, & TIP year-end awards by MDA, WDAMI,or TIP Organizations.

**Division(s) Rules & Regulations:**

*Novice Rider:* Rider is in the 1st or 2nd year of showing at any dressage show and may show only in this class for 2 years maximum, on any horse.

*Novice Horse:* Horse, with any rider, is in the 1st or 2nd year of showing at any dressage show and may show only in this class for 2 years maximum.

*Junior Rider:* Riders 18 and under as of January 1 of the current show year.

*Adult Amateur:* Riders 19 and over. Amateur refers to riders that obtain NO income from riding, training or teaching.

*Open:* Any age and professional.

*Leadline:* Open to any age rider.

*Eventing Test of Choice:* Riders may choose between Beginner Novice Tests A or B, Novice Test A or B, and Training Test A or B. Classes will be split by test, if enough entries. Please indicate your division on the entry form.

*Open Classes:* Classes will be split by AA, JR, Open, if enough entries. Please specify the Division you plan to ride on your entry form.

*Test of Choice Classes:* Classes will be split by test, or even AA, JR, Open if enough entries.

Please specify the **Level**, **Test**, and **Division** you plan to ride on your entry form. (FAILURE TO DO SO WILL RESULT IN BEING PLACED IN OPEN IF CLASSES ARE SPLIT.) Each ride must be ridden with a different test following USEF/USDF rules regarding showing consecutive levels.

If you are interested in a class we currently don't offer, please contact Violet at LPequestrianshows@gmail.com with your interest. Classes may be considered for addition.

**Coggins:** No entry will be accepted without a photocopy of a negative Coggins test for each horse brought to the show grounds (with the horse's name matching entry forms). A photocopy of a negative Coggins test dated within 12 months of the closing date of entered show must be submitted with each entry form. Entries submitted without a negative coggins test will not be accepted.

**Stall Fees:** Stall fees are \$50.00 per stall for the weekend. A separate, refundable \$25 stall cleaning deposit is due upon entry. (Refund given upon stall inspection.) Stalls are available after 2pm on Saturday. Reservations are accepted on a "first pay, first served basis". First bedding is not provided, but shavings are available upon request (\$8/bag or \$9 day of). STALLIONS MUST BE STALLED. Stalls after the closing date are non refundable in any circumstance.

**Horses Showing out of Trailers:** There will be a \$20.00 per day per horse tie-to-trailer fee for horses showing out of trailers.

**Non-Competing horse:** Horses wishing to school only must pay a non-compete fee of \$30.00.

**Veterinary Care & Farrier Services:** All local on-call vets & farrier services in the area will be listed on our show office bulletin board on Saturday during haul in. This is to ensure the most up to date and available services at that time.

**Entries:** Can be found on LP Equestrian Center FB Page , RING RADAR for digital entries & [www.lp-equestrian.com](http://www.lp-equestrian.com) and must be submitted via snail mail, email, or online form found on LP Equestrian Center website.

Entries close at 6 PM 2 WEEKS PRIOR TO THE SHOW. Payment can be submitted with a check sent to LP Equestrian Center, postmarked by the closing date, or online at lp-equestrian.com. You will be charged for all fees after this time with no refunds. There will be a \$25.00 blanket post entry fee per entry after this time.

- No entries will be taken over the phone.
- All entry forms must be completely filled out and signed.
- Checks should be made payable to LP Equestrian Center.
- All entry fees are non refundable after the closing date.
- There will be a service fee of \$40 for any non-negotiable checks.
- No class changes will be made after the closing date unless due to show management error.

Please make sure all final submissions are correct! Please call or text Violet at 586-935-7955 if you have any questions.

**Protective Headgear:** All riders must wear an ASTM/SEI approved riding helmet while mounted anywhere on the show grounds (professionals included). Any rider violating this rule will be immediately prohibited from further riding until the headgear is properly in place. LP Equestrian Center makes no representation or warranty, expressed or implied, about any protective headgear, and cautions riders that serious injury may result despite wearing protective headgear as all equestrian sports involve an intrinsic element of risk. Schooling will be available any show rings starting on Saturday after 2pm until ½ hour prior to commencement on the day of the show. Management reserves the right to limit schooling in the show rings as needed. Lunging is only permitted in designated areas and is prohibited on grass and in show arenas.

**Rings:** USDF Introductory, USDF Training Level Tests 1 and 2, WDAA Introductory, WDAA Basic, may be run in a 20x40m (small) arena. All other tests (USDF Training Level Test 3, First Level and above, and WDAA Level 1 and above) will be run in a 20x60m (standard) arena.

**Scratches:** After the closing date, cancellations for any reason are charged all fees without refund.

**Dogs:** Dogs must be leashed at ALL TIMES while on the show grounds (including handheld dogs). No dogs will be allowed in any schooling area, show ring, or in the secretary office.

**Smoking:** Is ONLY allowed in designated smoking areas. Butts must be disposed of in provided containers.

**Attire:** All riders MUST wear approved ASTM helmets while mounted. Boots with a heel, shirt/jacket with collar and sleeves required. Riders in Intro may show in a polo shirt with a collared neck and half chaps. Western dressage riders must wear show attire compliant with WDAA requirements. Chaps are optional.

**English and Western Dressage Musical Freestyles:** The Musical Freestyle class will be judged following the USDF guidelines for Training Level through Fourth Level, and the

WDAA guidelines for Intro through Level 4. The performance should clearly show the unity between rider and horse as well as harmony in all the movements and transitions. It is an open class, so that all levels of riders and all test levels will be combined for placings. A sound system will be available. Please have your music selections available as a MP3 on a device that can be plugged in using an auxiliary cord or a USB thumb drive, with a backup copy on a CD.

**English and Western Dressage Equitation Classes:** Open to all Adult Amateur, Junior, and Open riders. Riders will be judged on hands, seat, aids, performance of the horse, and harmony between horse and rider. The class is offered as Walk/Trot (Jog) or Walk/Trot (Jog)/ Canter (Lope). It will be performed on the rail and will show the gaits in both directions. Horses should back easily and stand quietly. A horse/rider combination is eligible for Walk/Trot English Dressage Equitation if they are not competing in above the Intro Level at the individual competition. A horse/rider combination is eligible for Walk/Jog Western Dressage Seat Equitation if they are not competing in Western Dressage above the Intro Level at the individual competition.

**LP Equestrian Center Awards:** Up to six ribbons will be presented per class at each show. Management may combine divisions based on entries. LP year-end championships will be based on attendance of shows and a points system. The division & level being awarded will also need a minimum of 5 riders per class in each division. Divisions may be combined in a level if there are less than 5 riders. Attendance of all dressage shows will be required to be considered for LP year end awards.

**LP Year End Championships Available:**

Year End Champion & Reserve Champion awards are given in the following divisions provided there is a minimum of 5 riders per class/division & not if they are combined.

**Intro:** Open, Junior, Novice Horse, Novice Rider, Adult Amateur

**Training Level:** Novice Horse, Novice Rider, Junior, Open, Adult Amateur

**First Level:** Open, Junior, Adult Amateur

**Second Level and Above TOC:** Open, Junior, Adult Amateur

**Musical Freestyle Western & English Combined:** Open, Junior, Adult Amateur

**Western Dressage Intro:** Novice Horse, Novice Rider, Open, Junior, Adult Amateur

**Western Dressage Basic:** Open, Junior, Adult Amateur

**Western Dressage Level One:** Open, Junior, Adult Amateur

**Western Dressage Level Two & Above TOC:** Open, Junior, Adult Amateur

**High Percentage Award:** One award may be given in Open, Adult Amateur, & Junior for each show day. The percent must be over 65.000

- Adult Amateur: Riders 19 and over. Amateur refers to riders that obtain NO income from riding, training or teaching.
- Open: Any age and professional.
